RAGGING

As per the orders of Supreme Court of India, Ragging is totally banned in Shri Shankaracharya Mahavidyalaya Junwani, Bhilai (C.G.) and any one indulging in Ragging is likely to be punished appropriately which may include Fine / Suspension / Detention from examinations and expulsion from the institution.
